## EARLY COURSE REGISTRATION

As an Early Action applicant, you can be one of the first students to register for your Fall 2018 semester courses. We hold several Student Orientation, Advising, and Registration (SOAR) programs on campus in the months of June and July. SOAR is a mandatory, two-day event designed to help new students make their transition to the University of New Haven. By attending an earlier SOAR program, you will receive a course schedule that ensures the proper track to a timely graduation. Early deposits will also be given first access to our **ROAD MAP FOR NEW STUDENTS**, an online module that allows students to complete placement tests and registration surveys prior to coming to campus for a SOAR program. Please keep in mind that SOAR programs and fall semester classes will fill on a first-come, first-served basis. Invitations to SOAR will be mailed out to Early Action deposited students beginning in the month of February.
