

Meeting opened by Nyle Davy at 6:05 pm. Lyn Chamberlain, Vice President for Marketing and Communications gave a presentation. Major highlights of the newly organized Department of Marketing and Communications include:

- Increase visibility, of the University
- To determine the "essence" of the University and make it immediately recognizable
- Express identity of the university to make it visible, resonant and actionable.
- Major goal is to put alumni forward.
- To use alumni as proof of marketing strategy
- Redesigned the website to put the business end in a password protected section, enhance the public area and make it mobile friendly. Mobile friendly launched in February with an immediate increase in hits.
- Major redesign in the website is ongoing. It is still in the design stage but is expected to be much more dynamic.
- Print material updated to include more, and updated information.
- Increased marketing is an effort to increase our visibility and increase our US News and World Report ranking.
- Alumni Magazine: Need a separate alumni magazine that comes out about 2 times per year. Should be in print. Hoping a new issue can come out in the fall around Homecoming time. Will also want an Alumni Advisory Board for the magazine.

Minutes: Minutes were approved as written. Motion approved by Arlevia and seconded by Tom.

Presidents Report:

- Several board members attended the Senior Seventeen "Meet and Greet".
- N. Davey and D. Galla attended the endowed scholarship dinner. Opportunity to make referrals to students to others.
- 5 Board members and their spouses attended the Scholarship Ball. 1.75 million dollars was raised at the Ball.

- N Davey attended Commencement on behalf of the Board. He noted that at the 75th anniversary of the university, the Alumni Board made a gift to the president of a medallion to include in the Commencement regalia. N Davey noted that we should consider a similar gift for the 100th anniversary.
- Annual Meeting will be held in Oak Lane in Woodbridge. Planning continues for a roundtable discussion with former Past Presidents of the Alumni Board.
- President Kaplan will like to attend another meeting in the early fall to address the board early in the school year. Steve Morin will also like to attend next year.
- Would also like to include a board member on the Undergraduate Student Council.

- The committee suggested we launch "Get Involved" to Past Presidents. Discussion at the round table may help engage the Past Presidents.

Advancement:

- Scholarship Ball was held on April 22.
- Thank you note program has launched. Please let Heather or Jenn know what thank you cards you would like to write. Today is last day.
- Financial participation of Board Members is about 65%

Program and Events:

- Worked with Tony Distasio to post events on LinkedIn.
- Lou presented a Law Day program on the 14th Amendment on April 5th. More than 40 attendees. Program was successful.
- Mentorship program met with new board members. Looking at previous alumni to serve as mentors.
- International micro-network working with Jackie Shu. They are working with applicants to help complete their school applications.

Marketing:

- Antonio and Chris Campbell launched a campaign on the website to get the alumni engaged around our benefits and services. Tony has worked to get the information on line
- WNHU micro network is in the early stages under the leadership of R. Sharpe. A letter has been sent to WNHU alumni to launch the micro-network. At least 20 alumni have expressed interest.
- The Marketing Committee is looking to be able to define what the Alumni Board is. They are requesting a couple of slides from each Committee Head to coordinate the development of a presentation to be used for marketing purposes and the recruitment of new board members.

Charger Statue: RFP was sent for return mid May. The completed proposals will be reviewed tomorrow. The Charger Statue may be the appropriate gift from the alumni for the Centennial Anniversary.

Centennial Celebration: no report

Office of Alumni Relation:

- Oak Lane will be the location for the annual meeting scheduled on June 20th
- The Senior Seventeen Program went well. Metrics from 2016 to 2017show an increase of 27% increase in student participation. The Alumni Dept. partnered with 40% more departments for this initiative. There has also been a58% increase in graduate school participation. A 25% increase in social media has also been realized.
- The Scholarship Ball was successful with about 1.75 million dollars raised.

Questionnaire results:

- Committees—Suggest that some members are involved in several committees. Would like to try to get each member to contribute to only one committee and commit to it. Don't over commit oneself. May leave time to attend events.
- How to enhance communication and improve board meeting content.
 Reports of committees should be brief as a committee report is prepared and distributed.
- A new alumni magazine is being launched which will highlight activities of the alumni office and alumni board. There will be integration of the Alumni Office and Board with the Magazine editorial staff. Input from the office and board will be welcome.
- Alumni office would like to establish new student traditions. Brittney is
 involved in student life and establishing student traditions such as the Senior
 17. The new Marketing Office is welcoming alumni office suggestions and
 contributions. "Where in the World is Charlie the Charger" is one campaign
 that originated from the Alumni office that will be supported by the Alumni
 Magazine

Other Topics:

• Steve Dunnigan suggested that the alumni office provide content programing. Suggest seminars or talks in certain career paths. Dawn Gratalo suggested a Lunch and Learn activity to bring in some industry experts.

- Goals for Membership Meeting are to recruit an international student to participant. S. Dunnigan suggests that we engage international student to present a program from an international perspective.
- Dawn Alderman noted that new initiatives are designed to mentor new grads. She suggests we look at other ways to recruit older alumni who may not be savvy using social media.
- Reece Buendia suggested that standing committees should be evaluated to determine if the current structure meets the needs of the Board. She suggested that committees might be formed to partner with individual colleges. This may allow the board to build a relationship with the college, this relationship can help to solicit ideas for lunch n learns or seminars.

Crowd funding/ Advancement;

- Reece is board liaison to the crowd funding initiative. Gifts can be small for new alumni and can be specific to their interest. Athletics, marching band and other student activities have meaningful projects can be supported. that is meaningful. The goal is to continue to bring active projects o the board's attention. If there is any connection, they can spearhead the communication and drive the fundraising. We would like to get more alumni to participate. Crowd funding works with the Annual Giving Team to get the projects approved and put on the webpage. Crowd funding is attractive to the young alumni.
- Can we support some of the students fund raising activities? The fundraising events like the "dance a thon" or others. If Alumni supports the crowd funding activities of the on campus groups that will resonate with the students.
- Discussion ensued that many new grads feel that the first contact with the University after graduation is only about donation. Heather noted that now the first call from the call center, to a new grad was not about giving, but was about touching base with the students to check in how they're doing. They offer support of the Career Development or notification of events.
- There is the potential to partner with Career Development to co-sponsor event and/or work together. Alumni office has a meeting with them in September to discuss.
- Dawn Alderman noted that Charger start up weekend is Sept 15-17th. If anyone is interested in participating, contact Heather.

Action Item: New and existing members—let Heather know what committee you are interested in participating with. Committee chair will be asked to submit meeting schedules in advance.

The Board trying to stay in tune to the Centennial Committee. Heather and Jenn are involved in the University's planning committee.

Charger statue is still being planned. Still trying to determine a location but a call for artist submissions has been initiated.

Questions and Comments:

- Can we identify alums by finding out who donated in last years?
- Jalen expressed his interest in creating a microgroup for Cybersecurity.


