### Update on Progress

William Carbone, from the TYJI at the University of New Haven, announced that applications were open for the 2019 Transforming Youth Justice Leadership Development Program, which is set to begin March 2019. William Carbone reviewed the agenda for today's meeting.

### Presentation: Transforming Juvenile Justice Systems to Improve Public Safety and Youth Outcomes

William Carbone introduced and welcomed Shay Bilchik, founder and director of the Center for Juvenile Justice Reform at Georgetown University, who was invited to present his most recent report to the JJPOC. Shay Bilchik applauded Connecticut for being a leader in data driven, research-based juvenile justice reform. Shay Bilchik then explained the six strategies that were developed in his report for transforming juvenile justice systems.

After the presentation, Shay opened the floor to discussion about the six strategies that were highlighted. Questions were raised including how implicit biases could be recorded and measured



during juvenile court proceedings as well how the system can develop ways for juveniles to navigate family influences.
