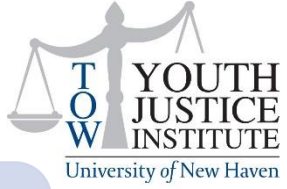

JJPOC Workgroups/Subgroups



Executive Committee

Diversion Workgroup

- Will continue to meet every other month.
- Subgroups on FWSN, Raise the lower age, and Truancy meetings will take place but with less frequency.

Cross-Agency Data Sharing Workgroup

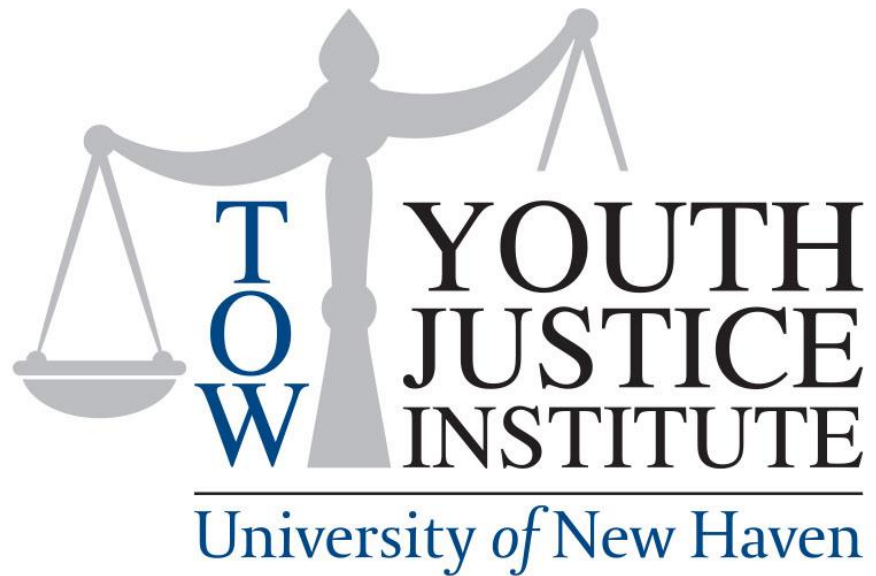
- Focus efforts on the three projects and will meet based on project(s) need.
- Auto Theft Subgroup will meet for an update in August and establish next steps.

Coordinated Effort on the Three Primary Projects

- Incarceration Workgroup receiving technical assistance from CCLP from July 2019-June 2020.
 - Conduct a review of other states' laws regarding the transfer of juvenile cases to adult court and the outcomes associated with those laws, including their impact on public safety and their effectiveness in changing behavior.
 - A subgroup will be formed to work with CCLP.
- Education Committee receiving technical assistance from Peter Leone from July 2019-April 2020.
 - Propose concrete, specific, and actionable solutions to improve education for out-of-home youth in the state's justice system.
 - Three subgroups (Infrastructure, Quality Control, Personnel)

Coordinated Effort on the Three Primary Projects

- Justice Reinvestment Project- technical assistance provided by the Council of State Governments Justice Center from July 2019-June 2020.
 - As part of the Improving Outcomes for Youth (IOYouth) initiative, the CSG Justice Center will conduct the most comprehensive assessment to date of Connecticut's juvenile justice system – from initial point of referral through reentry.
 - Taskforce will meet periodically to review analysis and recommendations.
- Coordinated Efforts:
 - Monthly meetings between the three consultants:
 - Ensure no duplication of work
 - Establish task and timeline
 - Coordinate data request, site-visits, and focus groups

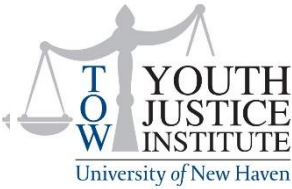

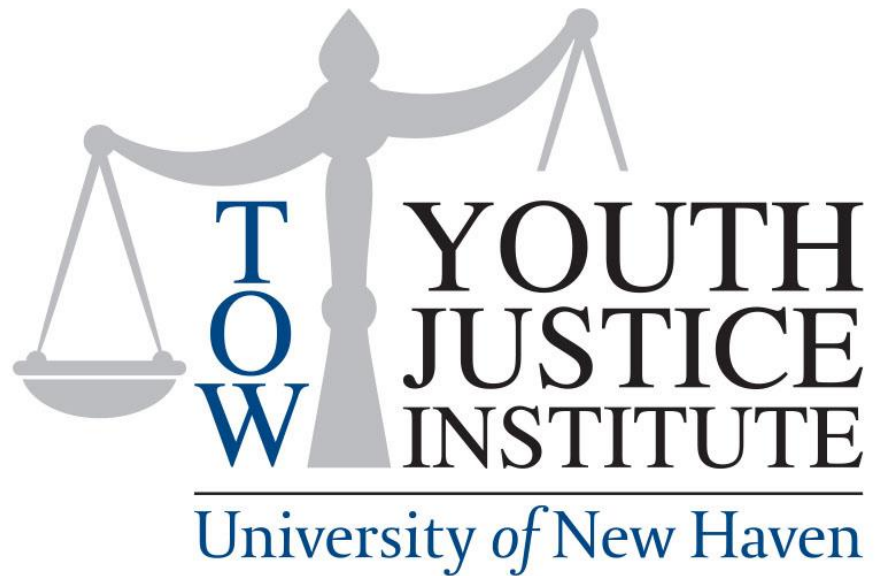

 - Assessment Measures



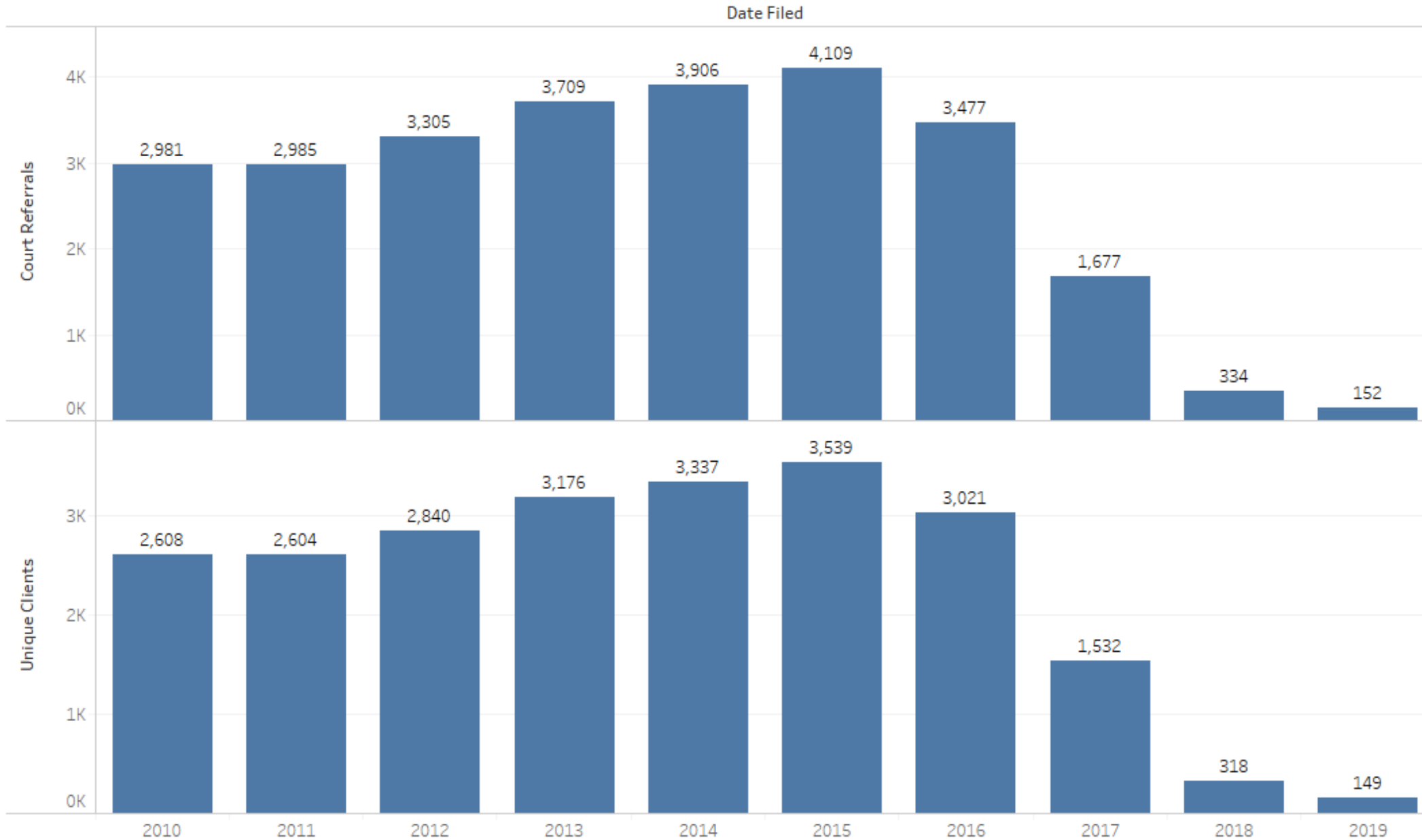

FWSN Data

- This collection of data was compiled by the Judicial Branch's Court Support Services Division (CSSD) for the JJPOC Diversion workgroup, and contains descriptive information about Family With Service Needs (FWSN) referrals to court during the period 2010 through May of 2019
- Data collection is an evolving process, and improvements made during this data range have allowed for greater availability of information. As such, such measures depicted in these charts is only available or reliable from 2014/2015 forward.

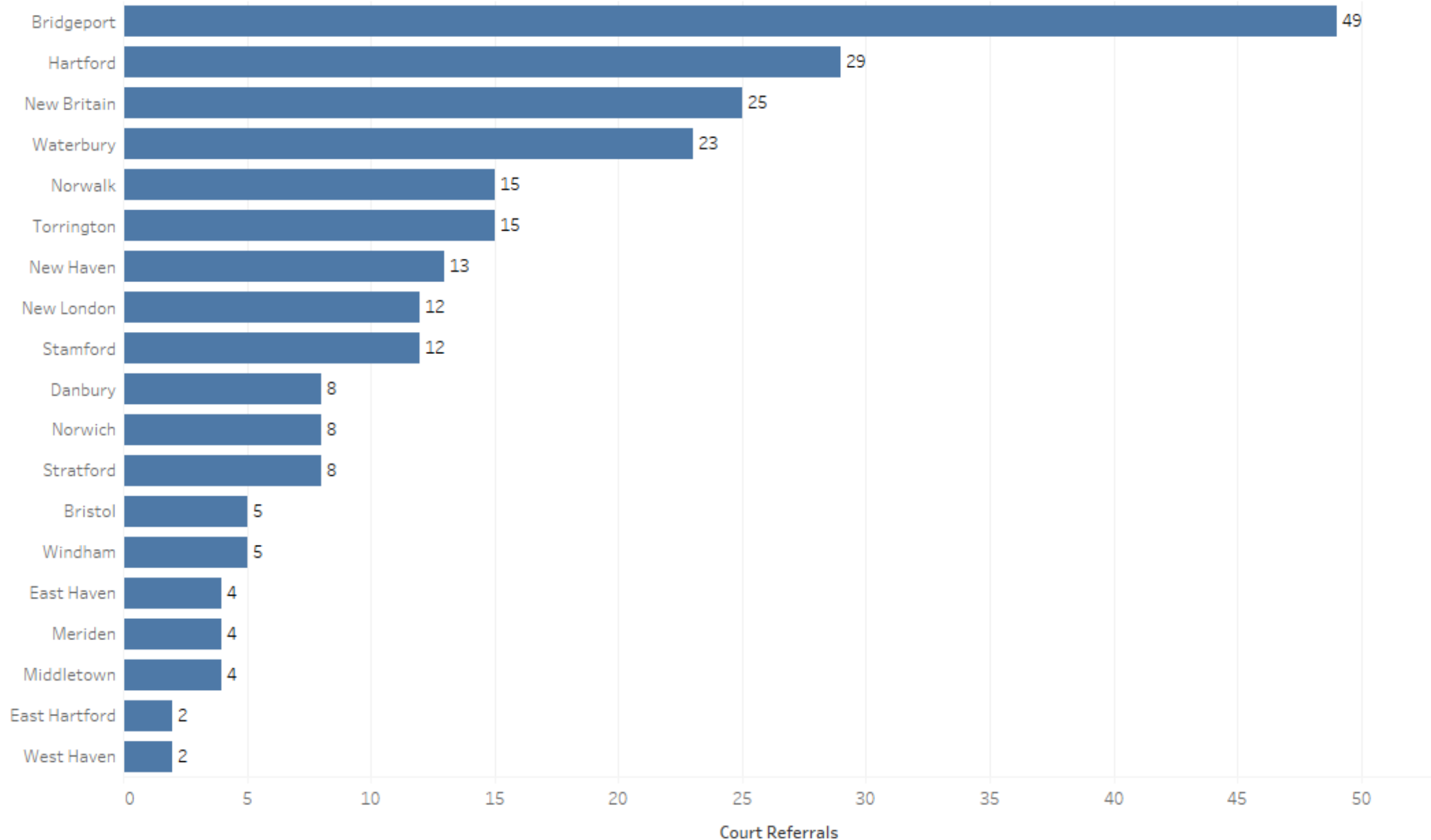
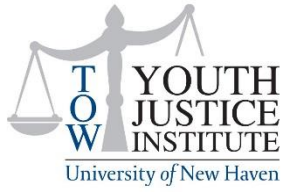
All FWSN Court Referrals by Calendar Year

INCLUDES Truancy and Defiant of School Rules



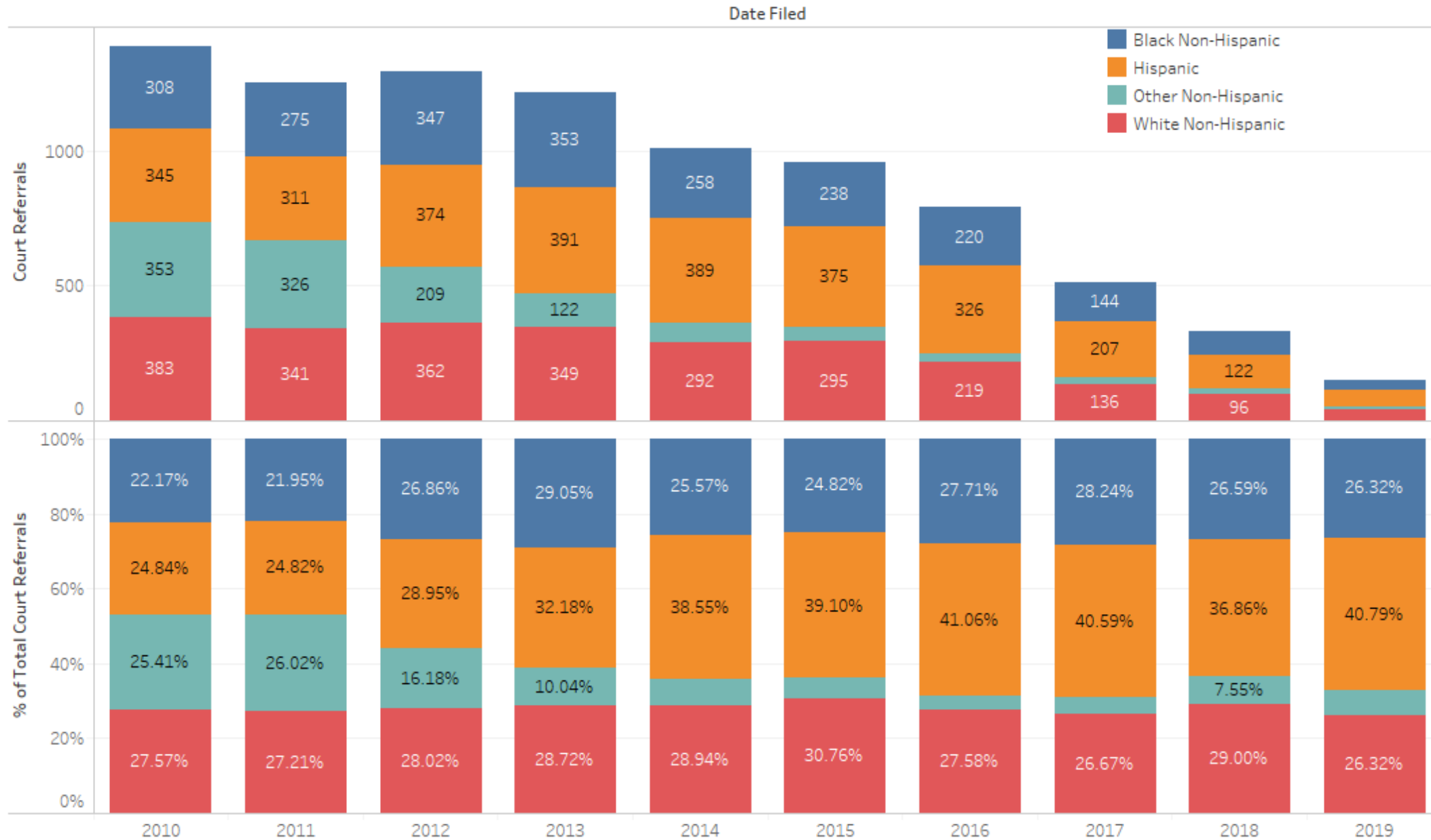
Top 20 Towns contributing FWSN referrals during 2018

Excludes Truancy/Defiance of School Rules

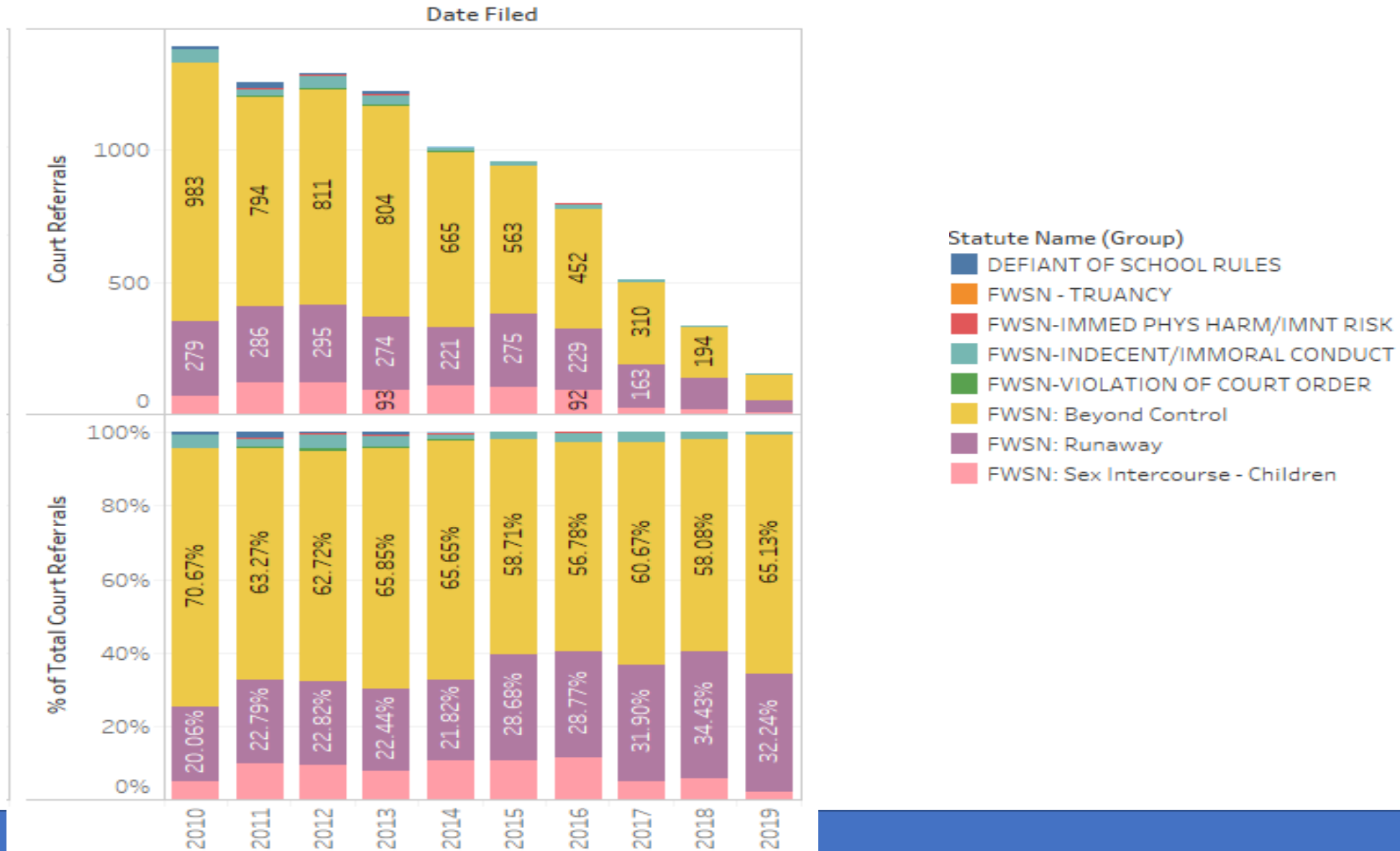


FWSN Court Referrals by Race/Ethnicity

Excludes Truancy/Defiant of School Rules

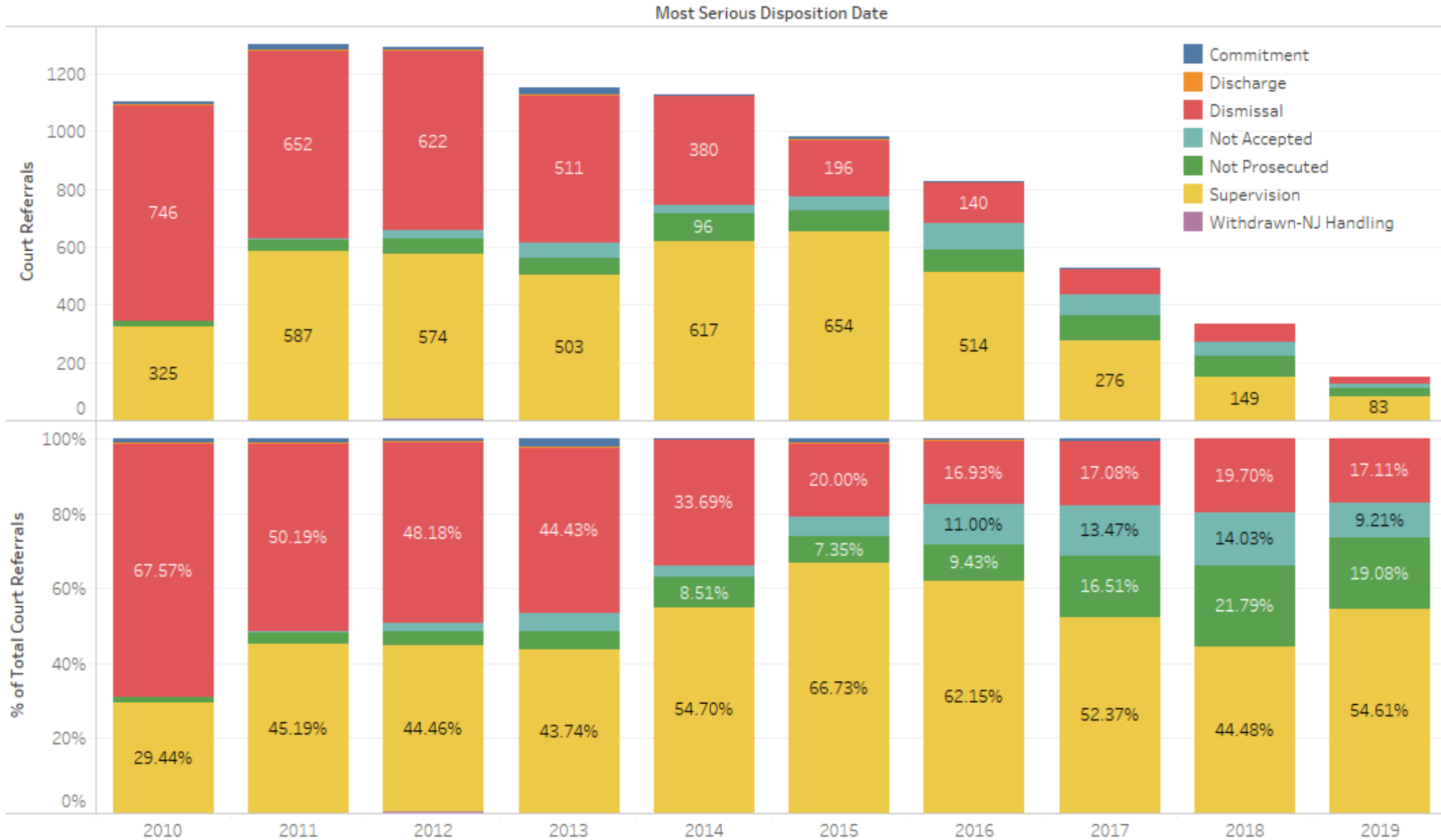


All FWSN Referrals by Charge Type Excludes Truancy and Defiant of School Rules



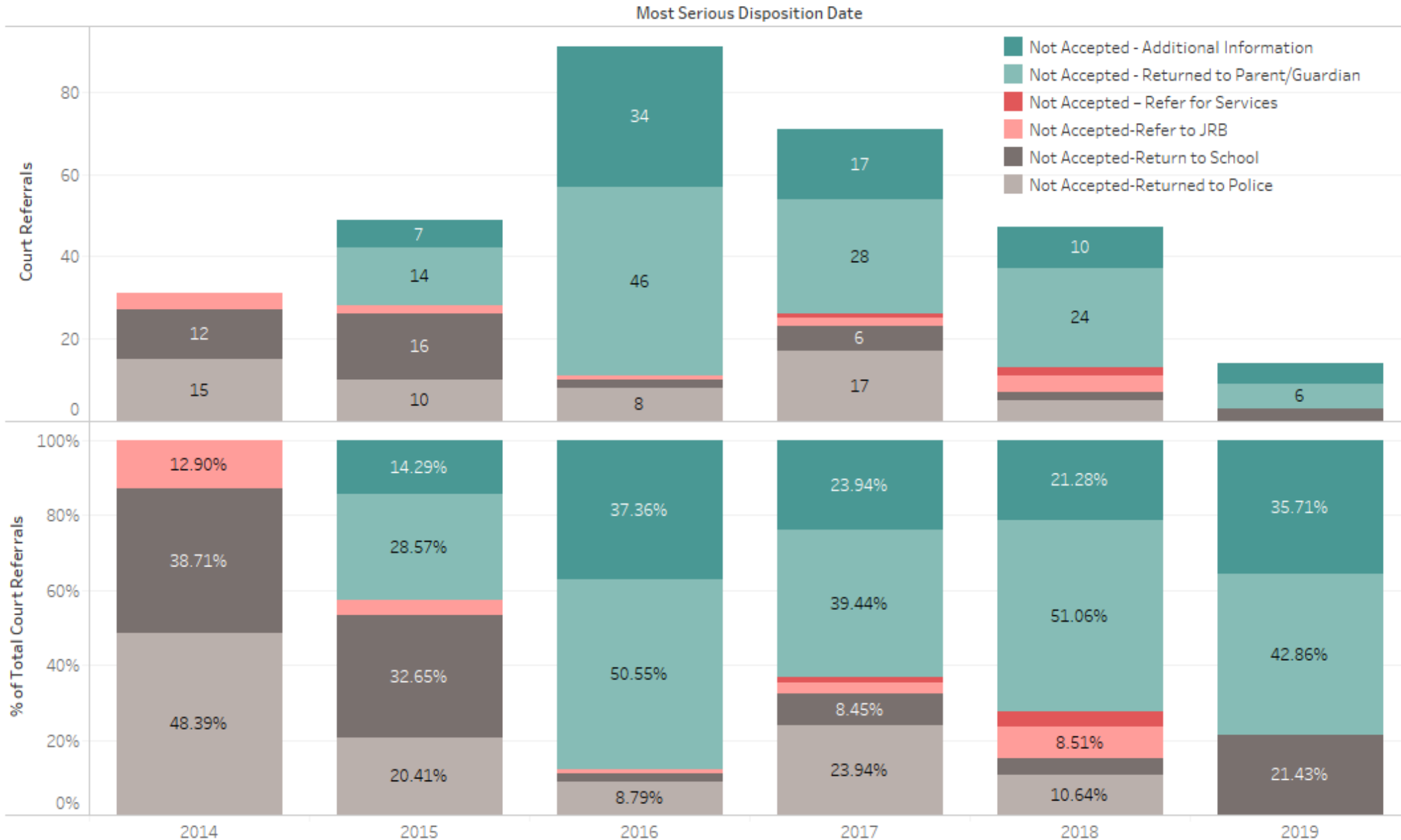
Disposition, by year of Disposition Date

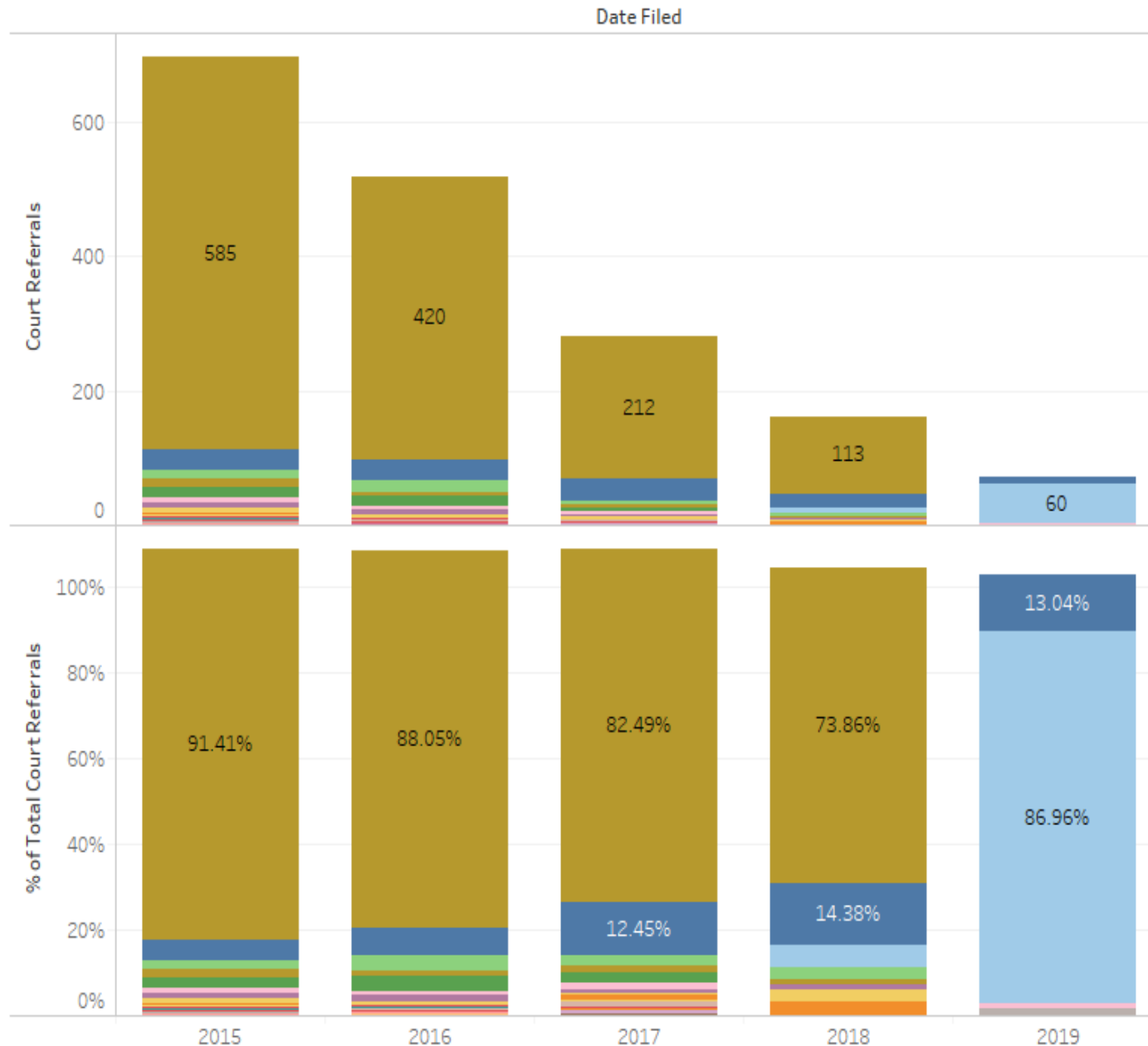
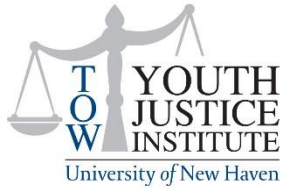
FWSN Referrals Not Accepted, by Disposition Type

Excludes Truancy/Defiance of School Rules. Includes only clients disposed to supervision. Data from 2015 forward.

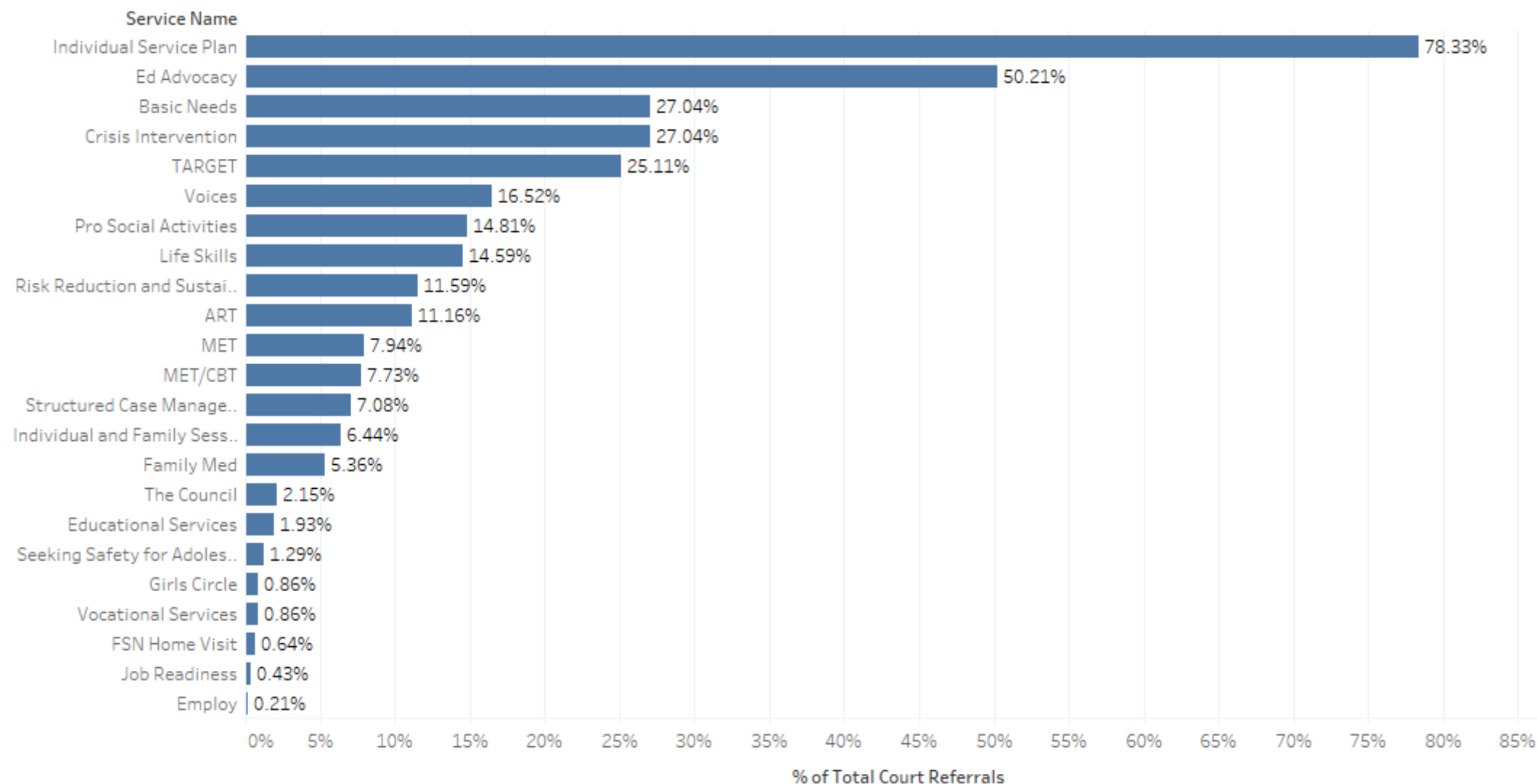
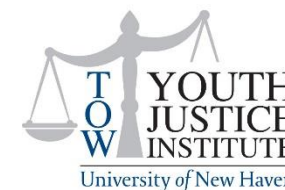

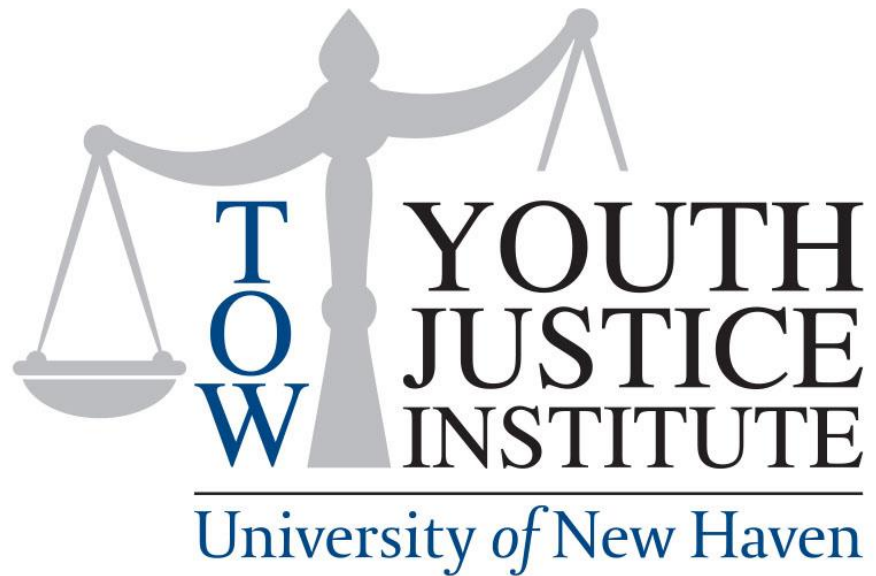
Treatment Interventions Received at CYFSC/LYNC, 2016-2019

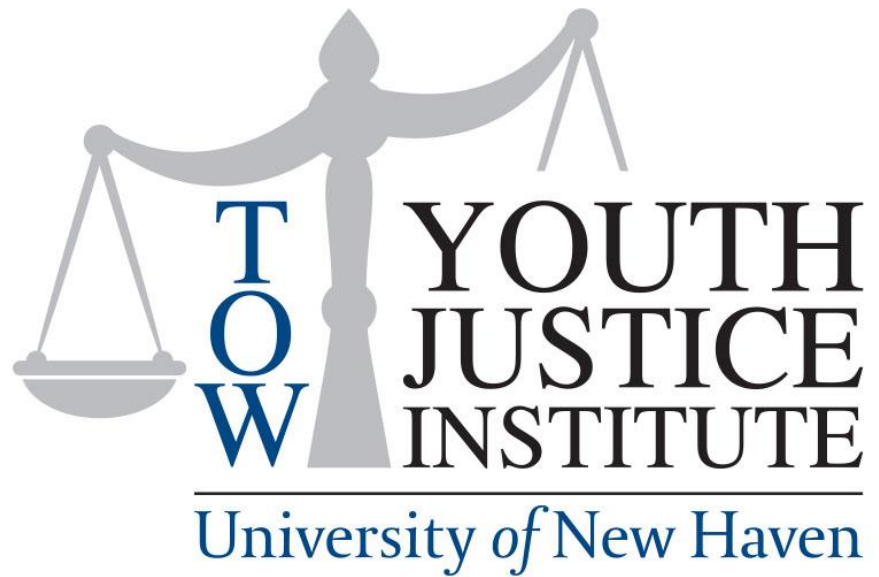


12-Month Delinquent Arrest Rate, for clients referred prior to 4/1/2018
Excludes Truancy/Defiance of School Rules

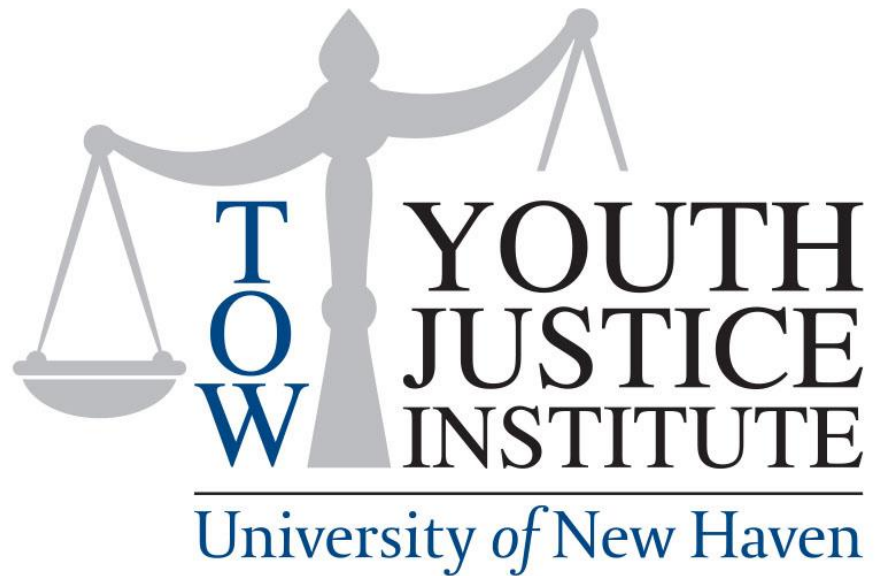
